The Indaba will focus on key sectors such as Energy Infrastructure, Water Infrastructure, Road and Bridge Infrastructure, Transport and Logistics Infrastructure, ICT Infrastructure, Circular Economic Infrastructure, Black Industrialization, Human Settlements, Social Infrastructure, Petrochemical Infrastructure, and aggressive skills development initiatives.



## What is the Purpose of the Built Environment Indaba?

We recognize that the challenges facing the built environment industry are extensive and complex, making it difficult for BBCBE to address them effectively on its own. This has underscored the need for collaboration by bringing together industry practitioners, academics, government officials, and representatives from infrastructure development ministries to convene at the Built Environment Indaba. This platform enables collective engagement, discussion, and solution development for a wide range of pressing issues. These include the slow pace of transformation, procurement reforms, incomplete projects, aging infrastructure, water and sanitation concerns, road and rail networks, load and water shedding, road network maintenance and construction, and the dismantling and redirection of apartheid-era spatial planning. Collaboration is the way forward.



# The Aim of the Indaba

The Built Environment Indaba serves as a vital platform for fostering collaboration among the public and private sectors, academia, researchers, civil society, and labor. Its primary objective is to address South Africa's pressing challenges related to infrastructure development and delivery across the infrastructure cluster and associated sectors.

The Indaba aims to drive innovation by exploring and developing practical financing and delivery solutions. It focuses on critical areas such as roads and transport, energy, and water security, bringing together diverse stakeholders to devise actionable strategies for overcoming these challenges.

The event also seeks to address critical issues within infrastructure development, focusing on key sectors such as roads and transport, energy, and water security. Through bringing together diverse stakeholders, the Indaba aims to create actionable strategies that improve infrastructure delivery, optimize procurement processes, and develop the necessary skills to support sustainable growth. This collaborative approach will drive economic transformation, create jobs, and ensure the long-term viability of the built environment in South Africa.

## The Event will focus on :

- Foster partnerships between government, private enterprises, and educational institutions.
- Promote dialogue on best practices in project delivery and resource management.
- Identify opportunities for public-private collaborations in infrastructure-related sectors.
- Focus on sustainable, inclusive growth that benefits all South Africans, particularly marginalized communities.
- Explore innovative infrastructure funding and delivery models that would speed up the delivery of economic and social infrastructure in South Africa.
- By aligning various sectors and stakeholders towards shared goals, the Built Environment Indaba 2025 will be an essential forum for transforming the future of infrastructure development in South Africa.

# The Event's Objectives

Building on the 2024 Objectives, the 2025 Built Environment Indaba objectives will be:

- To engage and collaborate with key government departments involved in infrastructure development in unpacking the implementation of current initiatives, policies, and long-term strategic plans that would advance the built environment transformation.
- To facilitate collaborative discussions between public and private sector organizations, academia, and civil society on innovative solutions for overcoming economic transformation bottlenecks and barriers.
- To emphasize the importance of targeted skills development and skills transfer, especially in the face of evolving infrastructure demands by creating an environment that would inform, educate and create access to skills development opportunities.
- To identify and promote procurement strategies that will drive transformation in the built environment thus changing the procurement practices in the public and private sector to embrace efficiency, transparency and participation by emerging contractors.
- To highlight and showcase key stakeholders and available opportunities in the built environment through exhibitions,
  - presentations, and networking platforms.
- To capture all proposals and solutions offered during the indaba, which would be explored for implementation in the pursuit of transforming the built environment.

The target for the 2025 Built Environment Indaba is to attract approximately 1000 to 1200 delegates daily for the two days duration of the indaba, to participate in the panel discussions and master classes.



## About The Organizer :

The Black Business Council in the Built Environment (BBCBE) was established in 2007, with the vision of lobbying and advocating for transformation in the built environment through the use of public legislation and policies. The initial organizational focus was mainly on the construction sector but over the last two years, the organization has expanded its lobbying and advocacy mandate to the full scope of the built environment, supported by intentional support in the implementation of projects and programmes. As a lobbying and advocacy organization, the implementation of projects and programmes provides an opportunity to measure the impact of the organization in driving transformation in key areas of the built environment within South Africa and Sub-Saharan Africa.
